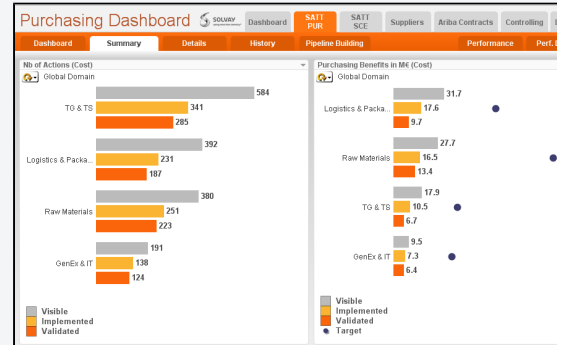

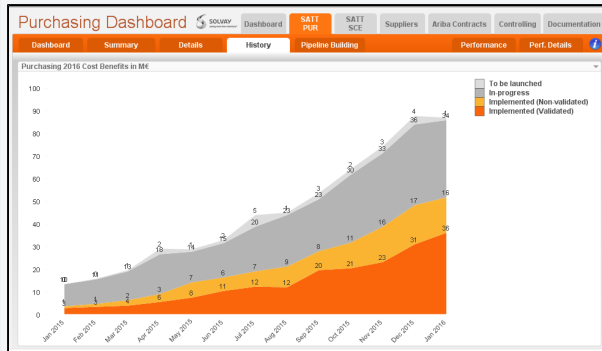
SATT Pur Summary

This screen displays the evolution of the benefit according to the status.



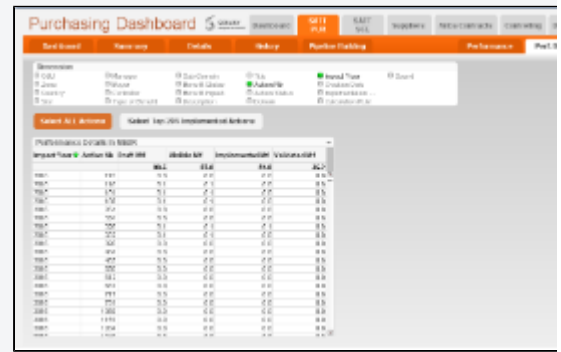
