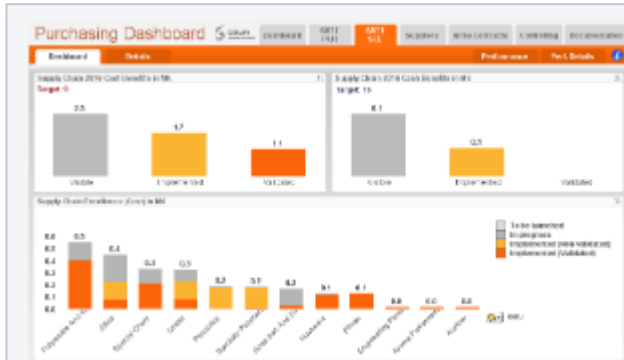

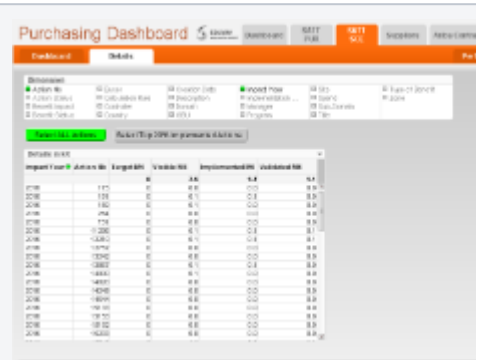

Main Definitions

Unit (M= Million, K= Kilo, U= Unit): SATT benefit impact is based on Euro units. However by default SATT Pur displays benefits per Month/Year.

Month/Year: This is the date of the last extraction from SATT tool.

G.B.U. (Global Business Unit): These are the businesses impacted by the purchasing actions. This business perimeter is set by the t of the action

Site: These are the location of the purchasing actions. The location is set by the buyer who is in charge of the action

Site country: these data raise from Site.

Domain (SCE): Global Purchasing Domain if the action comes from Procurement (Purchasing) program, click [here](#) to access to the Gf domain selected by the buyer who is in charge of the action. However, some domains dedicated to Supply Chain Excellence have bee TOLLING, TRANSPORTATION, PLANNING...)

Sub-Domain (SCE): Global Purchasing Domain, click [here](#) to access to the GPS' website. All Domains SCE are connected to the sub- Progressing, Inbound, Outbound etc)

Action Type: This is the strategy which will allow to get the benefit. This type of action is set by the buyer who is in charge of the action

Calculation rules: The buyer who is in charge of the action has been selected a calculation rules related to the expected benefit.

Program: Origin of the action, Procurement = Purchasing actions, Supply Chain Excellence = Supply Chain actions

On the bottom of the screens

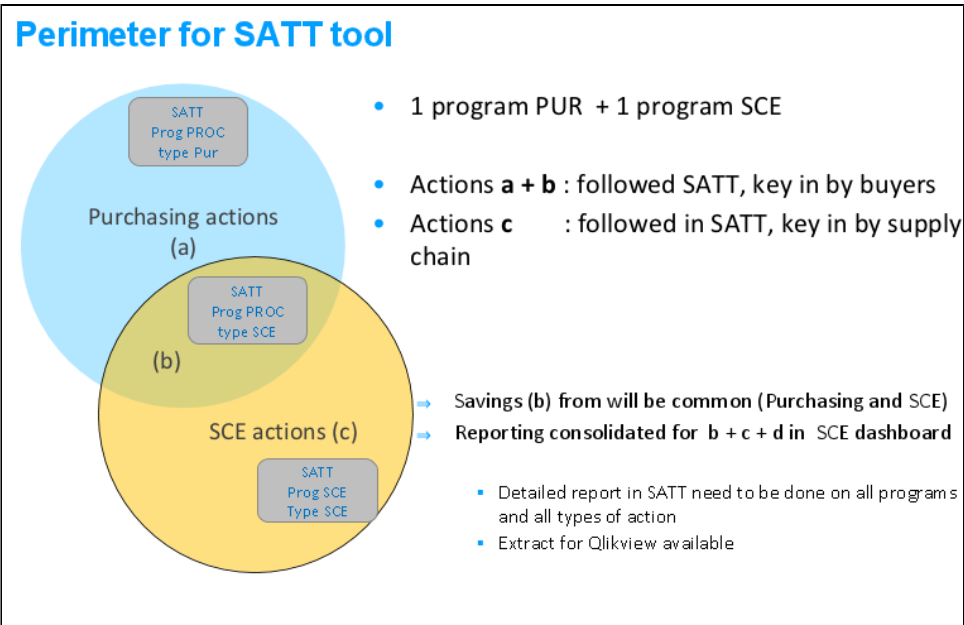
Manager: Manager who is hierarchical/functional responsible of the action.

Buyer: Buyer is the leader of the action.

Controller: These are the final approvers of the action, and they will confirm or will not confirm the achievement of the benefit at the er workflow.

Type of Benefits: Type of benefits raises from calculation rules. Yearly according to the Purchasing Strategy, the weighted and the sp are defined (see: **Calculation**).

Impact Year : Impact year is related to both information implementation year and benefit impact. Implementation date is set the beginr impact and benefit impact is set the duration of this benefit.
