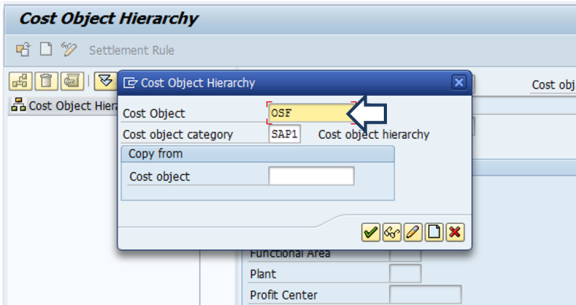


KKPHIE - Assign material

Enter

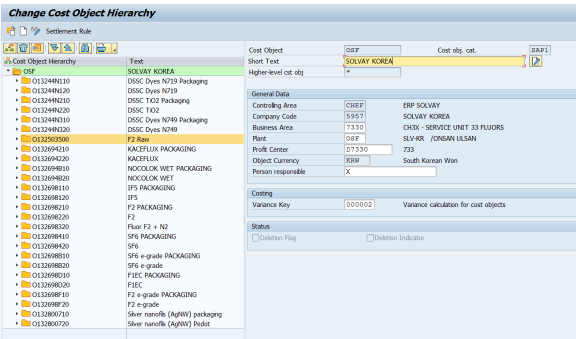


STEP 2

Then click on

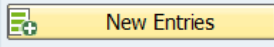


STEP 3
