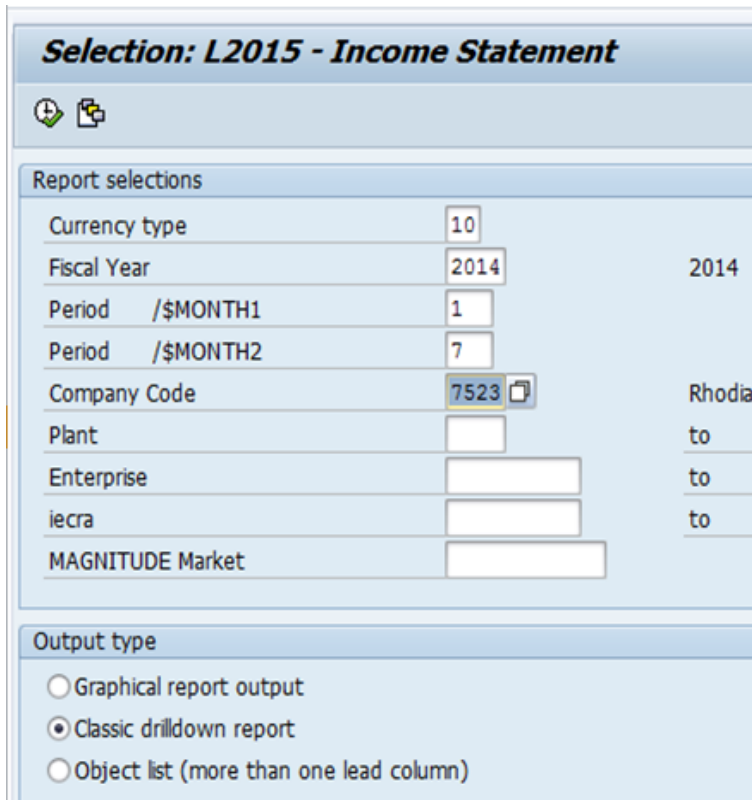
3.1. I extract the data from SAP

Go to transaction KE30 in SAP, insert the correspondent operating concern (e.g.: Z025 for Brazil), and choose report ZZZ-SOLVFC.

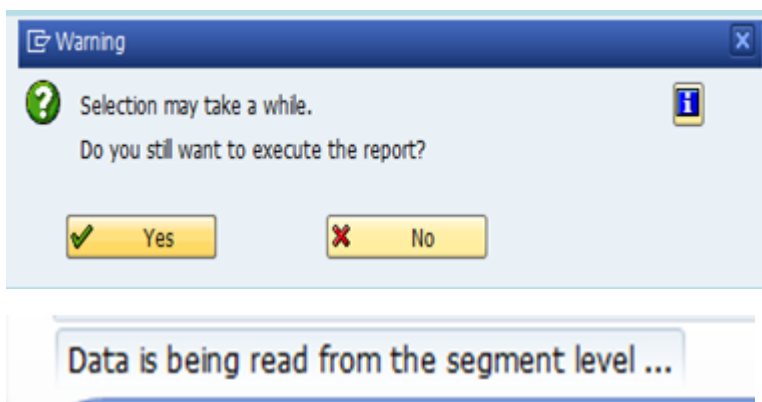


Make the following selections:

- **Currency Type:** Always "10"
- **Fiscal Year**
- **Period:** from beginning of the year until the current month
- **Company**
