Execute it.

Extract it to Excel - delete the columns/lines in blank, copy all data and paste in the file "RTR.IAC01.03 CK40N YYYY-MM" in tab "Datos" column C3 if it is the first running (for the second running, insert it after the last cell with information).



turn columns A and B into numbers, change column E from bar to point and delete the column P.

Delete all lines in blank and let only the lines which begin with material number.

For the columns A,B and S always check if the formulas are until the end.

Go to tab "Plan 1", select the 2 months that appear in the cell B1 and update the pivot table.
