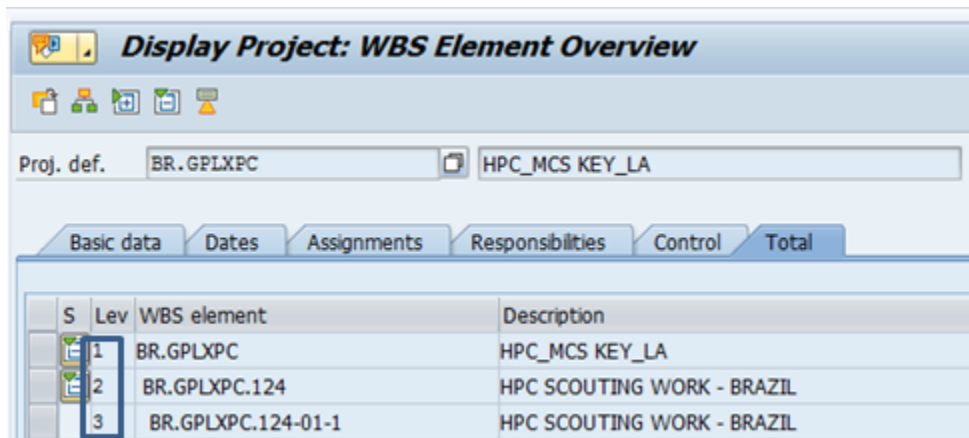

- 3rd - Subproject

The difference is in the field "level" that must be filled accordingly.
