## 1. PURPOSE AND USAGE OF BUSINESS STRUCTURES IN BFC

Syensqo IFRS reporting is organized per legal companies (one reporting package per legal company) reporting their Financial Statements (P&L, Balance Sheet and Cash Flow Statement) on a monthly basis. To allow Businesses to get their Financial results, **each legal company** will in addition **split its results on Business dimensions**.

The following items of Financial Statements require an allocation per Business:

- P&L until EBIT (Operating Income)
- Internal sales and external sales
- Working Capital (stocks, acc. receivables and payables), CAPEX (capital expenditures), Fixed assets and Investments
- Free Cash flow

It means that Group IFRS Consolidated results can be obtained as sum of legal companies and as sum of Businesses.

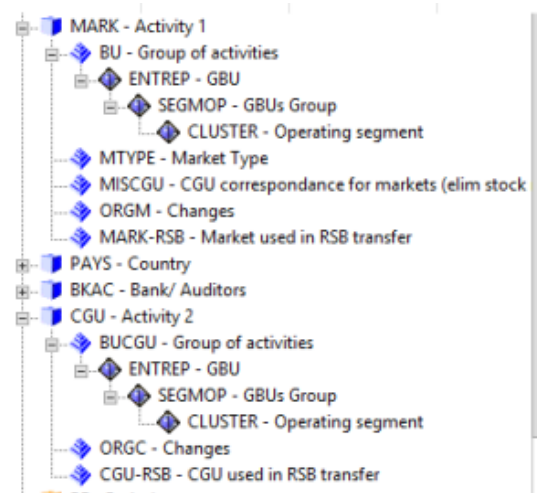
This IFRS reporting per Businesses is **used by both Businesses and Syensqo Corporate Controlling teams** to prepare the analysis of Syensqo Businesses performance included in both **Financial press releases every quarter and Annual report**.

To be noted that Business structures are also used in Controlling reporting categories (RSB and PREV).

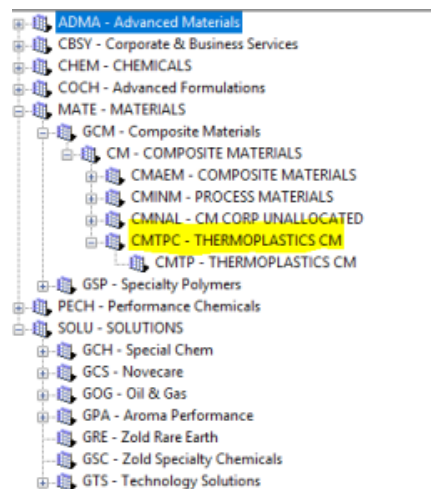
## 2. BUSINESS STRUCTURES HIERARCHIES IN BFC

Business structures are organized around **5 levels aggregating each others in a global hierarchy** (following a "Russian dolls" principle - 1 level can belong to only one upper level and never two):

- **CLUSTER = Operating segment**
  - This is the upper level of the hierarchy
  - Codification rule : 4 letters
  - Corresponds to the **level of external communication** on Syensqo Businesses performance
  - **Only used for retrieval purposes**, not as entry point for data entry
  - Example: MATE "Materials", SOLU "Solutions"...
  - Approval process for creation of new CLUSTER / update of content: Syensqo Corporate Controlling
- **SEGMOP = Group of GBU's = Operational Segment**
  - This is the 2nd level of the hierarchy
  - Codification rule : 3 letters
  - Used **internally to group GBU's** - not a level subject to external communication
  - **Only used for retrieval purposes**, not as entry point for data entry
  - Examples in Cluster MATE "Materials": GCM "Composites Materials", GSP "Specialty Polymers"...
  - Approval process for creation of new SEGMOP / update of content: Syensqo Corporate Controlling
- **ENTREP = GBU = Global Business Unit**

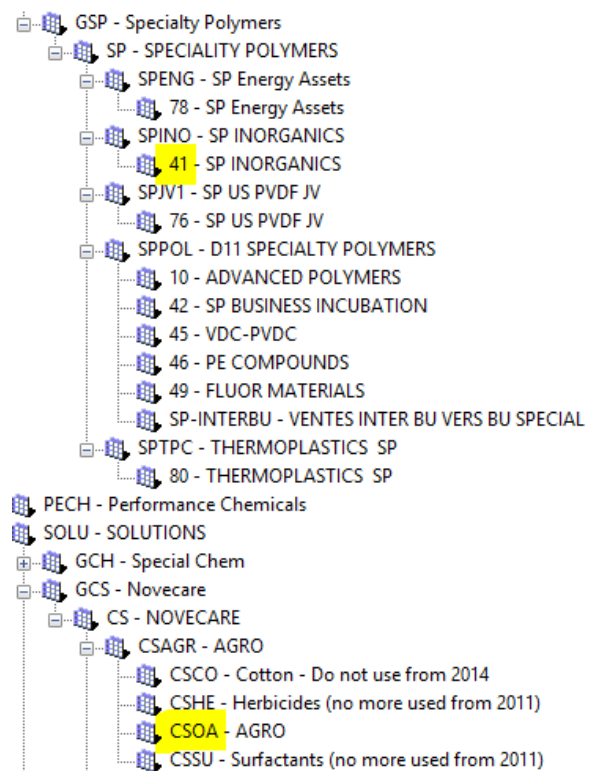


- This is the 3rd level of the hierarchy
  - Codification rule : 2 letters
  - **Used internally** - corresponds to the Business organization and management with Global Director, Finance teams...
  - **Only used for retrieval purposes**, not as entry point for data entry
  - *Examples in Segmop GCM "Composites Materials": CM "Composites Materials"*
  - **Exception / constraint on codification: do not choose codes starting with "D", "Dx"** codes dedicated to Discop GBU's (examples: DO "Discop Acetow" / DM "Discop Performance Polyamides"...), creation subject to request and approval from GAR
  - **Approval process for creation of new GBU** : Syensqo Corporate Controlling , on proposal made initially by Businesses
  - **Approval process for update on GBU's content** : Businesses
- **BU = Business Unit**
  - This is the 4th level of the hierarchy
  - Codification rule : 5 letters - the 2 first letters are the ones of the belonging GBU code
  - **Used internally** - allows each GBU to sub divide its activities (criteria considered to split can be external market, external application, product lines...)
  - **Only used for retrieval purposes**, not as entry point for data entry
  - *Examples in GBU CM "Composites Materials": CMTPC "Thermoplastics"*
  - **Exception/constraint: do not choose codes starting with "D", "DxDIS"** codes dedicated to Discop BU's (examples: DODIS "Discop Acetow"...) )
  - **Approval process for creation of new BU / update of content** : Businesses
  - Note that Business requests are subject to challenge from SBS FSL teams if they bring complexity (in setup and maintenance) without any demonstrated added value for performance follow up

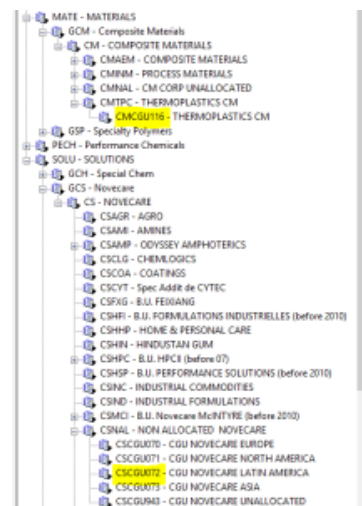


5th and last level combines 2 different dimensions : **MARK**  
**"Activity1"** and **CGU "Activity2"**

- **MARK "Activity1"**
  - **Level for data entry** in the IFRS reporting packages to enter **P&L components and Acc Receivables**
  - **Level also directly used in BFC customizing** (category scenario, consolidation rules, reports, Business users accesses...) and in **Journal manual entries** from Syensqo Corporate (GAR and Controlling)
  - Codification rule :
    - Different practices coming from the past - capital letters or digits
      - *example on the right side on GBU CS "Novocare" and SP "Spec Polymers":*
        - usage of digits in SP: example 41 "SP Inorganics"
        - usage of letters in CS: example CSOA "Agro"
    - **Best practice: it is recommended to cross check that any new Activity1 code proposed for BFC does not exist already :**
      - 1) in ERP's (PF1, WP1) with FSL SU MAC Master Data team
      - and 2) in BFC dimension builder (BFC Admin team to take care of it)



- **CGU "Activity2"**
  - **Level for data entry** in the IFRS reporting packages to enter **Working capital, Fixed assets and Investments**
  - **Level also directly used in BFC customizing** (category scenario, consolidation rules, reports, Business users accesses...) and in **Journal manual entries** from Syensqo Corporate (GAR and Controlling)
  - Codification rule :
    - Codes can combine letters and digits - the two 1st characters being the CGU abbreviation (example : CMxxxxxx for Composites materials)
    - **Best practice: it is recommended to cross check that any new Activity2 code proposed for BFC (for both Syensqo and Rhodia legacies) does not exist already:**
      - 1) in ERP (PF1, WP1) with FSL SU MAC Master Data team
      - and 2) in BFC dimension builder (BFC Admin team to take care of it)
- **Approval process for both MARK and CGU:**
  - Approval process for creation of new MARK and GBU : Businesses
  - Note that Business requests are subject to challenge from GBS FSL teams if they bring complexity (in setup and maintenance) without any demonstrated added value for performance follow up



## 3. OVERALL PROCESS FOR BUSINESS STRUCTURES UPDATES

### 3.1. PLANNING

Process of Business structures updates is organized **yearly** through a **"3 steps / waves"** cycle

Best practice is to **start in Q3 Y** the identification and setup of Business structures changes expected for Go Live Jan 1st Y+1

#### Wave 1 - October Y: **1st set of expected changes needed for Budget (Controlling cycle)**

- Needed for budget exercise in PREV reporting category
- **Only new structure items are created with "NEW " value in "Changes" characteristic** of both Activity1 and Activity2 reference tables from Dimension builder (to avoid usage in on going Y Actuals)

#### Wave 2 - December Y : **2nd set of changes (late answers from GBU's) / Creation of New objects in BFC**

- Late decisions from GBU's (not communicated earlier in October)
- **Only new structure items are created with "NEW " value in "Changes" characteristic** of both Activity1 and Activity2 reference tables from Dimension builder (to avoid usage in on going Y Actuals)

#### Wave 3 - end of January Y+1 : **Activation/Deactivation in BFC for Y+1 reportings**

- GO to be given by Syensqo Corporate Controlling - when Year end Y-1 results finalized (usually achieved around end of January)
- BFC set up launched **around January 25th** to have few days before January Y+1 reporting generation
- **In this last round:**
  - "NEW" values removed to blank
  - "OLD" values set up to block usage on Activity 1 & 2 not to be used anymore in Y+1 ACTUALS
  - updates in hierarchies content (change of links)
  - update of descriptions to add "Not to be used anymore from xxxx" when required
- **Not forgetting impacts on Business users accesses:** as Business accesses are based on GBU codes, any creation of a new GBU code is expected to require updates (new GBU code to be added) of accesses of Businesses users belonging to the new GBU
- **Not forgetting impacts on Filters from Dimension builder:** such filters have been created to allow artificial combination of several GBU's (to keep track of historical business structures)

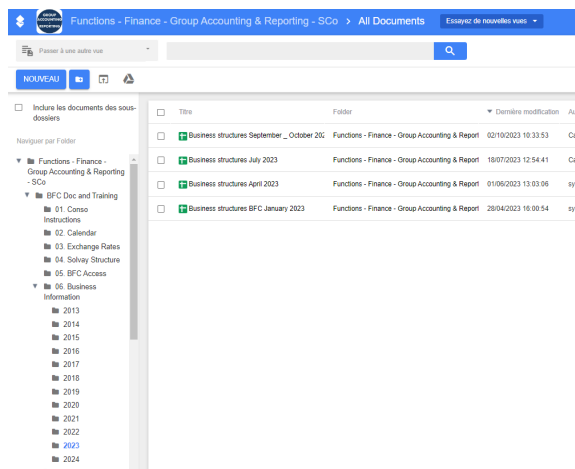
**Any change of Business structures out of this yearly cycle** (i.e. during the year) is **technically feasible** in BFC structures and ERP Master data tables. **However never recommended** as restatement of past months (since Jan 1st Y+1) is a heavy exercise in ERP's

## 3.2. ACTORS AND REFERENCE FILE TO COLLECT Y+1 BUSINESS STRUCTURE CHANGES

The following actors are involved:

- **Syensqo Corporate Controlling**
  - **Coordinates the collection of changes** with Businesses and inside Syensqo Corporate Controlling
  - **Challenges, when appropriate**, the proposed changes - can consult for advice FSL teams - BFC Admin and SU MAC Master Data team
  - **Communicates the changes received to BFC Admin and FSL SU MAC Master Data team**
  - **Controls the BFC set up** of changes of Business structures **before piloting to BFC Production database**

- **BFC Admin team:**
  - **Create and update the Reference file** gathering the BFC Business structures changes for Y+1
    - **File maintained in a Google sheet format - [Link to example "Syensqo 2025 Business structures"](#)**
    - When finalized , Reference file is **posted in GAR SYENSQO AODOC Team site** - 1 folder per year **Year Business Structure files**



- "Y+1" Reference file is created from save as of "Y current business structures" Reference file
- Then it is updated **highlighting the different type of changes required for Y+1** (received from Syensqo Corporate Controlling):

- **New objects** to be created and used from Y+1 reportings - *green background in the example on the right side*
  - As explained earlier in this procedure, BFC Admin will **propose the BFC codification**, checking with FSL SU MAC Master Data team that no constraint with ERP's
- **Old objects** not to be used anymore from Y+1 reportings - *pink background in the example on the right side*
- **Change of links (transfers)** inside hierarchies
- **Simple renaming in description** - *orange background in the example on the right side*

- Once changes collected and new required codifications validated, BFC Admin will **perform the associated BFC customizing**
- **Updates Business users accesses and Business filters**, when required, occurs before January Y+1 reporting

- **FSL SU MAC Master Data team:**
  - **Challenges when needed** the requested changes
  - Ensure **coordination** of Business structures **updates in the ERP's** with Business Data Administrators, FSL Master data teams and IT
  - **Collaborates with BFC Admin** to align on BFC codifications
  - **Ensure communication and global coordination** within Finance network (FSL, Businesses...)

## 4. CREATION / UPDATES OF BUSINESS STRUCTURES IN BFC

### 4.1. CREATION OF NEW OBJECTS

**Timing : Wave 2 - December Y**

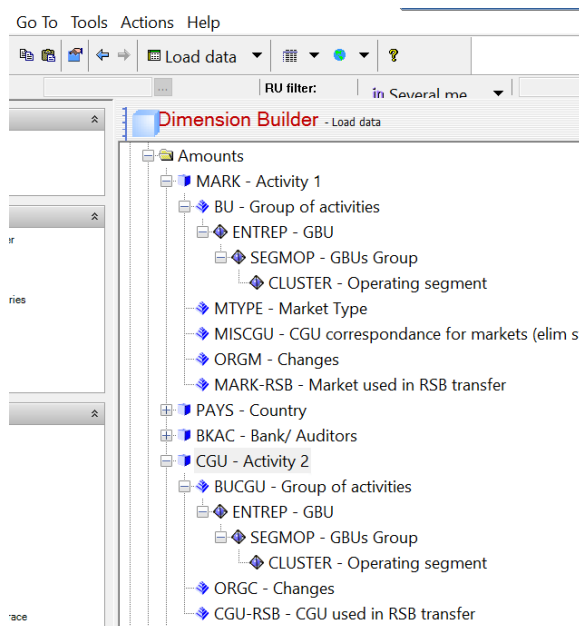
**Sequence of creation: From upper levels to lower ones**

- In case of **creation of new objects at each level of the hierarchies** and linked each others , it is **recommended to start the creation at the upper level of the hierarchy.**
  - *Example below creation of a new Activity 1 associated to a new BU => BFC Admin will create 1st the upper level (BU) and then after the lower one (MARK)*
- Also recommended to start 1st creating new CGU "Activity2" codes and then after new MARK "Activity1"

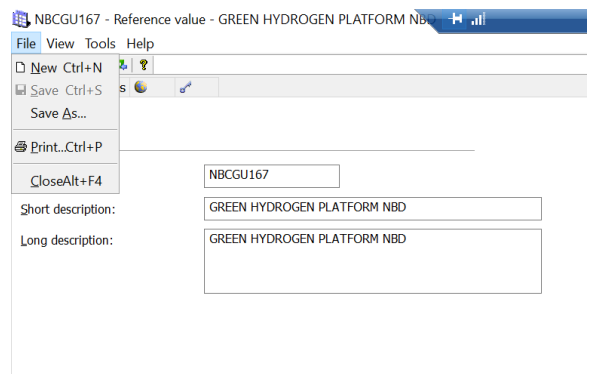
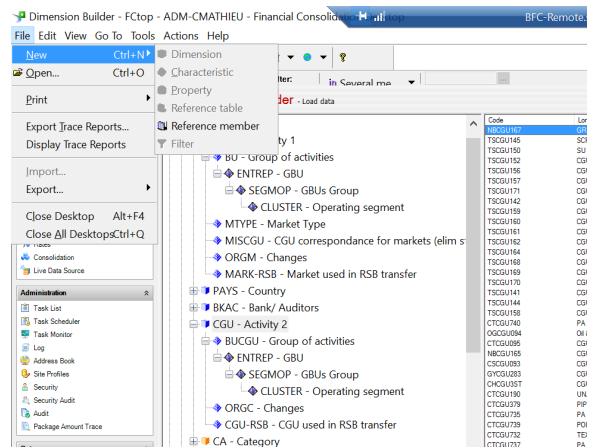
Select the **"Dimension Builder"** module in the **"Setup"** domain.

Then select the **MARK** and **CGU** dimensions and expand the hierarchy to access to the upper levels.



### 4.1.1 Creation of new CGU "Activity 2"

A CGU can be created from scratch in the option "**New Reference Member**", or through "**Save As**" from an existing CGU code.



In the tabs "**General**" and "**Translation**", enter the information in the following fields **as indicated in the Reference file**:

- Code
- Short description - EN & FR (same ones)
- Long description - EN & FR (same ones)

In the tab "**Properties**",

- **Group of activities:** **COMPULSORY** characteristic
  - Enter the belonging BU value defined in the Reference File

  - **Before Jan Y+1:** "**NEW**" value to be selected - this is will prevent from usage in on going Y reportings

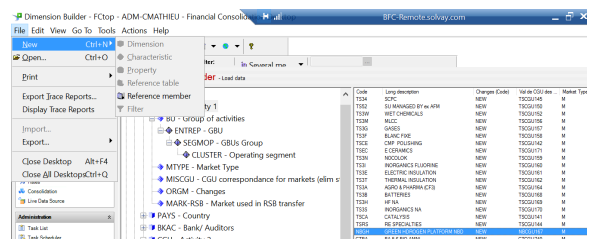

### 4.1.2 Creation of new MARK "Activity 1"

A MARK "Activity 1" can be created from scratch in the option "**New Reference Member**", or through "**Save As**" from an existing MARK code.



In the tabs "**General**" and "**Translation**", enter the information in the following fields as indicated in the Reference file:

- Code
- Short description - EN & FR (same ones)
- Long description - EN & FR (same ones)

- **MARKET type:** **COMPULSORY** characteristic
  - **4 different possible values:**
    - **M** "Market" - most common value
    - **E** "Entreprise" - this value has to be selected for new MARK created to host unallocated activities of the GBU (codes such as xxNR)
    - **PM** "Generic market partner code" - this value has to be used for new fictive MARK created to host inter BU's sales inside the same GBU (codes xx-INTERBU where xx stands for the GBU code) - usually 1 generic market partner code created for each GBU
    - **DISCOP** - this value has to be used for new MARK created to host Discontinued activities (post M&A items) - such value are requested by Corporate teams
  - Refer to the value indicated in the Reference File
- **CGU value (valeur de CGU des marchés):** **COMPULSORY** characteristic
  - This field allows to link MARK and CGU, link that is **needed to manage elimination of margins in inventories in the IFRS consolidation process** (Margin elimination in P&L requiring a MARK value and in Bal Sheet Stocks requiring a CGU value)
  - Refer to the value indicated in the Reference File

Special case of 1 CGU transferred and split into 2 or more CGUs: In the corresponding "new" MARK codes we can assign only one CGU.

Example: In 2022, TSDP and TSFU were transferred from TSDPH to TSMIN BU. Corresponding CGU associated to both TSDP and TSFU was split into 2 "new" CGUs. Business must choose which CGU should be assigned to TSDP and TSFU replacing the old CGU.

- **Changes:**
  - Before Jan Y+1: "NEW" value to be entered - this is will prevent from usage in on going Y reportings
  - End of January Y+1, "NEW" value will be remove and field will stay empty => the new object will be available for usage in Y+1 reportings

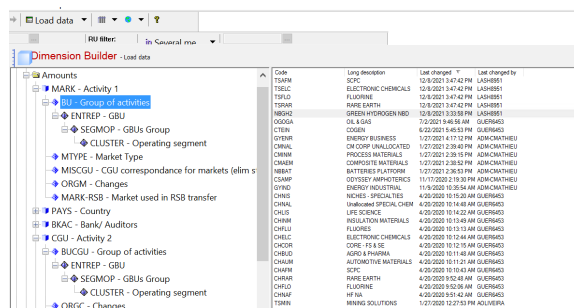

### 4.1.3 Creation of new BU

A BU can be created from scratch in the option "New Reference Member", or through "Save As" from an existing BU code.

Note that it can be created either using the MARK or the CGU hierarchy (no need to create twice in each as 1 single BU table common to both hierarchies).

Note: **No need on BU level to manage the specific f characteristics existing on MARK and CGU** (change, RSB transfer, value for margin in inventories...) as BU level is not used for data entry but only for retrieval purposes.

- Code
- Short description - EN & FR (same ones)
- Long description - EN & FR (same ones)

#### 4.1.4 Creation of new GBU / SEGMOP / CLUSTER

Customizing principles are the **same** than the ones described for the BU "Business Unit" level.

Note that those levels can be **created either using the MARK or the CGU hierarchy** (no need to create twice in each as single tables for each GBU SEGMOP and CLUSTER levels common to both hierarchies).

Note: As on BU level, **no need on those levels to manage the specific characteristics existing on MARK and CGU** (change, RSB transfer, value for margin in inventories...) as they are not used for data entry but only for retrieval purposes.

## 4.2. UPDATE OF OBJECTS: "OLD" & "EMPTY" VALUES (MARK"Activity1" and CGU "Activity2" levels only)

**Timing : Wave 3 - end of January Y+1**

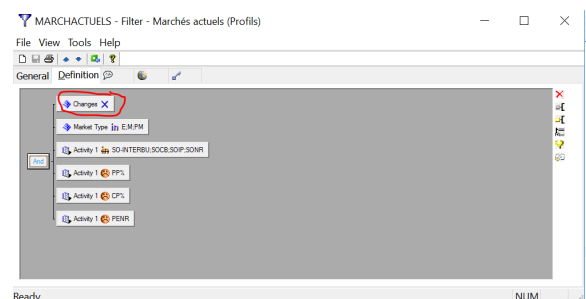
Select the "**Dimension Builder**" module in the "**Setup**" domain.

Then select the **MARK** and **CGU** dimensions and expand the hierarchy to access to the upper levels.

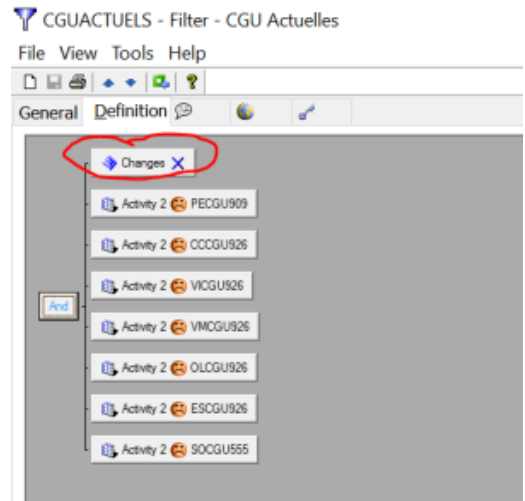
### 4.2.1 Switch from "NEW" to "EMPTY" value on "Change" charateristic

Doing this move, the **new created object (either MARK or CGU)** will **become available for usage in package data entry in Y+1 ACTUAL's reportings** thanks to filters integrated in BFC users accesses providing accesses only on **MARK and CGU objects with EMPTY value on "Change" characteristic** :

- Filter "**MARCHACTUELS**" for MARK dimension:
  - contains MARK with empty value (meaning of the "cross" blue icon) on "Changes" characteristic



- Filter "**CGUACTUELS**" for CGU dimension:
  - contains CGU with empty value (meaning of the "cross" blue icon) on "Changes" characteristic

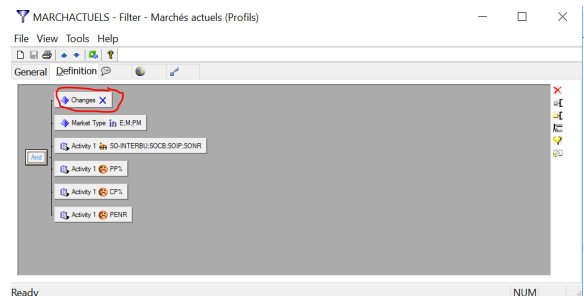
- **Changes:**
  - "NEW" value to be removed and field to stay empty - follow the instructions from the Reference file to get the list of objects subject to this switch end of January

#### 4.2.2 Flag as "Old" on "Change" characteristic / Register (if any) value on "RSB transfer" characteristic

Doing this move, the existing object (either MARK or CGU) expected not to be used anymore from Y+1 will become blocked (unavailable) for usage in package data entry in Y+1 ACTUAL's reportings thanks to filters integrated in BFC users accesses providing accesses only on MARK and CGU objects with empty value (different from OLD and NEW) on "Change" characteristic :

- **Filter "MARCHACTUELS" for MARK dimension:**

In addition to the "OLD" value, **characteristic "RSB transfer" may have to be filled in to automate RSB restatements** (through dedicated consolidation rules).

Such rules will transfer P&L / Bal Sheet items from OLD CGU/MARK codes (used in Y-1 Actual's reportings) to the NEW ones (used from Y+1 Actual's reportings). This will **allow Business users to compare Y-1 and Y+1 results using the same Business structures (Y+1 one)**.

Example:

- CGU code CHCGU234 to be flagged as OLD as replaced by new CGU code TSCGU145 => in "CHCGU234" CGU code: "TSCGU145" will be the CGU code to be declared in "RSB transfer" characteristic
- MARK code CH34 to be flagged as OLD as replaced by new MARK code TS34 => in "CH34" MARK code: "TS34" will be the MARK code to be declared in "RSB transfer" characteristic

- CGU (or MARK) used in RSB transfer: OPTIONAL characteristic**

- this field is used in RSB consolidation rules to automate some transfers between CGU (or MARK) from an old to a new code)

## 4.3. CHANGE OF LINKS INSIDE HIERARCHIES (ANY LEVEL INSIDE THE HIERARCHIES)

Timing : Wave 3 - end of January Y+1

This move has **not impact on data entry in reporting packages**. However, it **impacts the aggregation of each level and thus Business results obtained in retrieval reports**.

Note that **MARK and CGU hierarchies are not subject to any historisation/archiving**. This means that **any transfers** inside will **apply immediately to all reporting periods (past, current and future)**. This is why set up of manual filters (MARK and CGU dimensions) can be requested to BFC Admin by Syensqo Corporate Controlling to artificially rebuild the past hierarchies aggregations and allow data retrievals on the past results using those filters.

Connect to BFC\_Top\_SCO:

Select the "Dimension Builder" module in the "Setup" domain.

Then select the **MARK** and **CGU** dimensions and expand the hierarchy to access to the upper levels.

Transfers / change of links can be:

- either transfers of a CGU "Activity2" or a MARK "Activity1" from one BU to another BU
- or move of a BU "Business Unit" from one GBU to another GBU
- or move from a GBU from one SEGROP to another SEGROP
- or move from a SEGROP from one CLUSTER to another CLUSTER

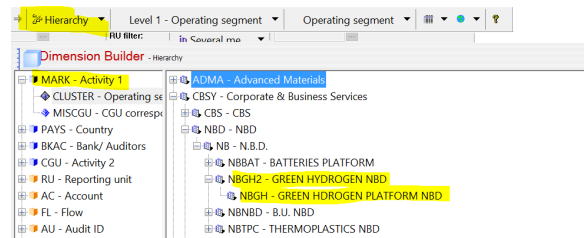

## 7. RELATED IMPACTS ON BFC USERS ACCESSES

**Timing : January Y+1 + "on flow" during Y+1 in case of GBU creation**

**3 types of users in BFC:**

- **Corporate and Transversal teams:** as they **operate on a WW basis**, usually no restriction on legal companies and on Businesses
- **Accounting teams** - data entry: usually **accesses granted using filters on legal companies** - meaning that no restriction on Business dimensions
- **Business teams (controllers, FD's...)** - retrievals: usually **accesses granted using filters on GBU's (1 or several granted)** - meaning that no restriction on legal companies (access to legal companies reporting on those granted GBU's)

As a consequence, **Business structure changes impacts Business accesses in BFC each time a new GBU is created**

**Process to be followed:**

- **Ask GBU FD (Finance Director)** who in his/her team has to get access to the new created GBU (support / advice can be requested from Syensqo Corporate Controlling if needed)
- Once list obtained, **process the updates in BFC Users module** - Refer to the **BFC Users Access management Procedure** for more details:
  - **New Filters in MARK and GBU dimensions from the Dimension builder)**
  - **New values on data entry analysis accesses**
  - **New values in Data access groups**
  - **Users accounts updates**
- **Inform the impacted users** of new accesses granted
- **Complete the related Internal Controls** (archiving answer from GBU FD as evidence) - Refer to **BFC Internal controls procedure**

## 8. RELATED IMPACTS ON BFC FILTERS FOR RETRIEVALS

**Timing : January Y+1 + "on flow" during Y+1 in case of GBU merge or spin off**

When GBUs are merged or splitted it may be useful for historical data retrieval to have a filter that includes the old GBUs that were previously separated or combined.

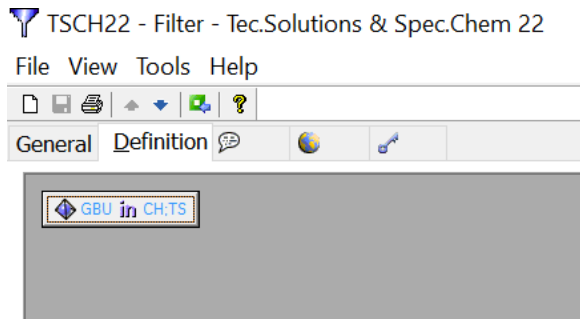
Examples :

- As of January 2022 the entire Special Chem. GBU (CH) has been transferred to Technology Solutions (TS)
- July 1st 2021, O&G (OG) GBU has been created from transfer from O&G activities previously hosted in both Novecare (CS) and Technology Solutions (TS) GBU's

In the 1st example, if a BFC end user wants to retrieve data prior to 2022, previously hosted in two GBUs (TS and CH) and now in just one, he /she can use a filter (combining CH and TS) and that way get the data collected for the 2 GBUs.

Such need must be always confirmed by Syensqo Corporate Controlling before creating the filter in BFC.
