CCCCUT	To be used for Utilities cost centers	Assessment Cycle
CCCCID	To be used for Indirect cost to production cost centers	Assessment Cycle
CCCCIN	To be used for Insurance cost centers	Distribution Cycle
CCCCCL	To be used for Product CC and shutdown CC	Assessment to CO-PA
CCCCPA	To be used when the allocation is to COPA ( normally, only TPT)	Assessment to CO-PA
CCCCDV	To be used when the allocation is using Distribution cycle.	Distribution Cycle
CCCCEX	To be used for Exceptionnels cycles. Where it can not be clasified in the above ones.	Assessment Cycle
CCCCTE	To be used only in SF1 for the test. CC to be blocked..	Assessment Cycle
CCCCPE	To be used for allocation of FC and Dep of the period from Production CC to Reporting CC	Assessment to CO-PA
CCCCAB	To be used for allocation of FC and Dep Absorbed in the Inventory during the month	Assessment to CO-PA
