Managing the Procurement Risk at Syensqo

Managing the Supply/Service Risk Discrepancies at Syensqo

The ultimate goal of supply risk management is to ensure there will never be a shutdown or a slow down at a plant due to a supply issue.

To do so, you need to have a systematic approach based on 4 steps.

- Be proactive within the risk identification (it includes to conduct some assessments based on scenarios)
- Intensify the cooperation with the Syensqo Group Risks team
- Use a real time risk monitoring tool: currently not available - expected to launch with SyWay project
