### What is Risk Radar?

#### WHAT IS RISK RADAR?

Risk Radar is a tool from Sphera (previously called RiskMethods) which monitors the supply chain by automating and accelerating detection of events which can impact Solvay's operations. Risk Radar compiles information from open source data (geo-risks, country-risks) and from premium data (if subscription).

#### HOW IS IT WORKING?

Buyers receive notification per email when a risk is identified on his/her supplier or locations he/she monitored (example: harbor). Buyer can log into Risk Radar to have an overview on his suppliers.

### How Risk Radar is currently used?

#### How

**After receiving an alert:** contact the supplier to ensure the event has no impact on our operations, build an action plan if needed.

**To prepare the supplier meetings:** log into the Risk Radar platform and look at the different alerts and score (especially from a financial perspective)

### What is the process for creating and updating the list of users, suppliers, locations, etc.?

A limited number of suppliers can be monitored in Risk Radar. Therefore, a request form will be required to add and remove a supplier.

For supplier update and creation/update of location, Syensqo sites and supply chains, you can do it by yourself directly in Risk Radar or you use the Request Form.
