

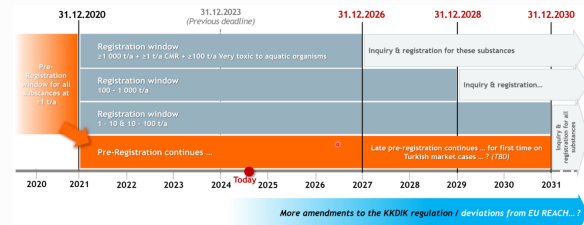

KKDIK

THE TURKISH REGULATION ON CHEMICALS REGISTRATION, EVALUATION, AUTHORIZATION AND RESTRICTION On the 23th of June, 2017, the Turkish Ministry of Environment and Urbanization (MoEU) has issued the promised Turkey **KKDIK**, regulation that will be enforced from 23 December, 2017. The Turkey REACH like-law: **KKDIK** is closely harmonized with the EU REACH provisions and requires companies to pre-register and register substances (on their own, in mixtures or in articles) manufactured in Turkey or imported into Turkey with volumes equal to or above 1 tone per year. **KKDIK will replace following regulations:**

Regulations	Effective date
– The Inventory and Control of Chemical Regulation (KEK)	23 June, 2017
– Regulation on Restrictions for the Manufacture, Marketing and Use of certain Dangerous Substances and preparation	23 December, 2017
– Regulation on Safety Data Sheets for Hazardous Substances and Mixtures (GBF)	31 December, 2023

Indirect Exportations

What is Indirect Exportation?

Indirect export is when a non-TR company represented by **REACH Global Services – RGS** as their **Only Representative – OR**, sells substances to another non-TR company (**customer/Indirect Exporter – IE**) and this IE then uses the substances in their products to sell the finished products to Turkey.

What does the Indirect Exporter (IE) need to do to be covered under the registration number?

First, IE needs to inform their supplier (company represented by RGS) about their exportation. By informing the supplier, IE has shown their interest in coverage under the registration number. RGS will create an account in RGS Portal so IE can enter their exportation information (volume per downstream user shipped to Turkey).

The system keeps the IE's information confidential, and only allows IE to enter their data to be covered under the OR, and cover both direct and indirect exportations of the companies we represent. In this context, please be informed that for the IEs using our system there will be a minor annual fee for the support and services we provide to indirect exporters.

As RGS, based on Article 8 of REACH Regulation 1907/2006, we are very meticulous in fulfilling our obligations as the OR, and cover both direct and indirect exportations of the companies we represent. In this context, please be informed that for the IEs using our system there will be a minor annual fee for the support and services we provide to indirect exporters.
