27th February 2025	IND-HSE-OH-08-PRO	Group requirements in occupational health (v1.3, 2025) Mainly for Syensqo rebranding and minor changes on travel health service provider.
9th October 2023	IND-HSE-OH-03.01-GUI	Medical management of expatriates (v2.0, 2023) Modified recommendations for organization (with HR International Mobility team) of the medical surveillance follow up of employees who will be either expatriated or missioned during periods longer than 3 months.
27th June 2023	IND-HSE-OH-10.08-GUI	First aid and medical recommendations in case of burns (v2.2, 2023) Modified recommendations in case of chemical burns and electrical burns.
