- Legal entity (BFC code) is the legal entity that sold the goods.
- Material code of the goods.
- Revenue type, which can be one of those shown below

- Total Sales is the sum of the sales amount of the last 3 months' sales grouped under that revenue type (column revenue type) and related to the material and legal entity pair.
- Currency of the sales amount. It must be the legal entity's local currency.
- Total Quantity is the sum of the quantities of goods sold within the last 3 months' sales grouped under that revenue type (column revenue type) and related to the material and legal entity pair.
- Unit of measure of the sales quantities amount.
- Sales Price is the result of the division of the total sales amount by the total sales quantities and multiplied by the price unit (1000). Price unit is always 1000 to avoid a rounding effect.
- Variation % / previous sale price is the percentage of variation of the current sales price compared to the previous month.
- Variation % / before previous is the percentage of variation of the current sales price compared to the price before the previous month.
- COPA Items is the number of COPA records involved in the unit sale price calculation.
- COPA Itms is the number of COPA records from sales record type F (Billing documents) involved in the unit sale price calculation.
- No previous sale price / No before previous sale price are indicators informing if there wasn't no previous sale price exist / no before previous sale price exist.
- Status, which can be one of those shown below.
