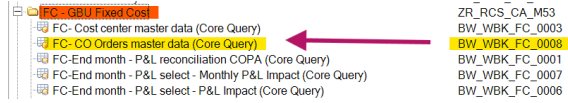


FC - Internal Orders master data

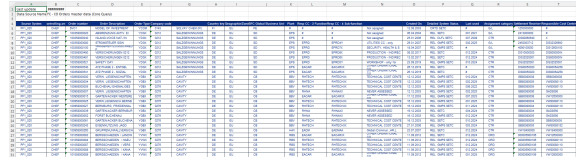
It is used to control the consistency of the CO Orders master data.

Order status = **CLSD** are excluded from the report.

1. the CO order master data coming from **KO03 - Display Internal Order**:
 - Source System
 - Controlling Area
 - Code & description
 - **Order Type**
 - Company code & Description
 - Plant
 - **Responsible Cost Center**
 - Created On
 - Detailed System Status
 - The following information is coming from the **Settlement rule of the CO order**:
 - Last used
 - Assignment category
 - Settlement Receiver
2. the 2nd and 4th levels of the **ZCBS** hierarchy
3. Other information:
 - BFC GBU is coming from the **profit center** of the responsible cost center in WP1 and from the **business area** of the responsible cost center in PF1
